**(Pairing of Judges)**

***SUPERSEDES ADMINISTRATIVE ORDER NO. 06-07***

**Each active judge opposite a retired or senior judge is hereby designated to hear all matters that would normally be heard by the retired judge, or, in the case of a senior judge, when the senior judge is not available, except that where a senior judge is presiding on misdemeanor calendar, cases heard by the senior judge will remain on the calendar unless the senior judge orders otherwise.**
